RIDER DECLARATION

I, the undersigned,

with the driving licence number _____

with respect to my participation in the “METZELER THE EPIC RIDE Experience” event to be held on 13–14 July 2021 at the Nürburgring/Nordschleife in North Rhine-Westphalia, Germany (hereinafter referred to as the “Event”), hereby irrevocably acknowledge that Pirelli Tyre S.p.A., PIRELLI DEUTSCHLAND GmbH or any of their subsidiaries or sub-subsidiaries (as well as their agents and representatives) (hereinafter collectively referred to as “Pirelli”) shall not be liable under any circumstances for any loss or damage arising in connection with the Event unless such loss or damage is due to Pirelli’s wilful intent or gross negligence.

It is expressly pointed out that the event is aimed exclusively at experienced motorcyclists who can demonstrate race track experience. I guarantee to be an experienced motorcyclist and to have race track experience.

I further acknowledge that Pirelli has not made any checks on my riding ability and suitability and that Pirelli will not make any warranty or guarantee in respect of these matters. In particular, I hereby declare and confirm that I am an experienced and responsible rider and that I will use all vehicles entrusted to me, including expressly the rented motorbike of the type BMW S 1000 RR intended for me with care and at my sole and exclusive risk and assume all responsibility resulting therefrom.

The race will be exclusively on the Nordschleife; I will comply with the rules applicable there. I further undertake to comply with all applicable laws and regulations, including the laws and regulations applicable to the operation of motor vehicles (the Highway Code) and, in the event of a breach of said law or regulation, to bear full responsibility for these, including the payment of fines and fees in accordance with applicable laws.

I agree to indemnify and hold Pirelli harmless from and against any and all liability in respect of claims arising out of or in any way connected with my participation in the Event, and I hereby waive any and all liability and enforcement in any action against Pirelli in this regard.

This declaration shall be governed by and construed in accordance with German law. Any dispute arising out of or in connection with this Declaration, including its interpretation, enforceability, execution, termination, or cancellation in which the parties cannot agree among themselves shall be referred to the state jurisdiction in which I reside or am domiciled, or, at my option, in which Pirelli is domiciled except if Pirelli is summoned by a third party to appear before another court for an event covered by this Declaration and relating to me; in this case I may also be summoned by that other court.
